Message from the President



Friends of Scotus.

By the time you receive this report, I will no longer be serving Scotus Central Catholic as its president. What a great experience this has been for both Peg and me. You cannot truly understand what it means to be a Shamrock until you have the opportunity to walk these halls on a daily basis. I truly believe I am a better person (far from perfect) because of my experiences the past sixteen years. Peg and I will miss you. And again, thank you staff, students, parents, alumni, and Scotus supporters for your trust and support.

The 2015-16 year was a year of challenges and incredible success for our school! I cannot express the pride I feel for the accomplishments of our student body and particularly of the senior class. Scotus had ten Omaha World Herald Academic All-Staters in the Class of 2016 including Lydia Schaecher, who was selected for the

All West-Central Academic First Team. Lydia was also a National Merit Finalist. The following nine Shamrocks were named Honorable Mention: Bailey Braun, Justin Brockhaus, Leah Engquist, Amy Heusinkvelt, Dana Hoppe, Gabrielle Middendorf, Ryan Mustard, Darin Rinkol and Justin Zoucha. (Honorable mention nominees either had to be ranked first or second in their senior class or they had to have an ACT composite score of at least 32 or a 2080 on the SAT.)

Scotus earned two NSAA Cups for activity achievements this year. The Shamrock boys won state titles in football (Class C-1) and soccer (Class B); took third in basketball (Class C-1) and golf (Class B); tied for third in track and field (Class B); finished fourth in boys cross country (Class C-1) and dual wrestling (Class B); and fifth in tournament wrestling (Class B). Scotus finished third in state journalism (Class B) and received the maximum points available in the district music competition, while the girls' volleyball team finished in fourth place (Class C-1) and the girls soccer team's final ranking was fifth (Class B.) We also had 36 NSAA Academic All-State selections this year.

On the financial side our supporters surpassed the annual appeal goal of \$65,000 and contributed more than \$142,000 to help the school make improvements to facilities and small team transportation. We lowered the HVAC debt, from \$454,591 to \$190,000, and the \$1.3 million dollar SEF 14 drive continued toward a successful completion at the end of 2016. We greatly expanded the computer network and server capacity of our school through an Ignite the Faith Campaign grant, added eleven power half racks in the weight room, and purchased another home and moved it to expand the new north parking lot for students. I could go on and on.

It was very easy to join this school sixteen years ago—who wouldn't want to work at a school where education of the mind, heart, soul and body are all given equal importance—where faith in our Lord can be expressed and nurtured every hour and where a storied tradition leads to confidence and success in the classroom and on the playing field and performance stage. It will be hard to leave Scotus Central Catholic but I am confident that Jeff Ohnoutka will be an outstanding president for SCC and the school will have a very bright future.

As Scotus embarks on another important Scotus Education Fund drive this fall, I urge you to continue your loyal support for a place that will provide generous returns for every dollar or volunteer minute you invest in the Catholic education of our students. May God bless all Shamrocks and may God be praised for the opportunity we all have to be Shamrocks!

NOTE:

The real estate taxes (2015) on the last two properties demolished for the north parking lot were paid this fiscal year and totaled \$567.82.

PARISH TUITION ASSISTANCE

The three Columbus parishes support the annual Scotus budget with parish tuition assistance—effectively providing a scholarship to each Scotus student that was valued at \$2,252 in the 2015-16 school year. St. Anthony parish provided \$158,764; St. Bonaventure provided \$384,376 and St. Isidore provided \$292,460—with the support levels based upon the number of students enrolled at Scotus from each parish. In addition, parish tuition assistance is supplemented with the annual income distribution received from the Walter & Josephine Rambour endowed fund (\$133,953 in 2015-16.) This endowed fund has a corpus value of \$3,128,337 and was established to support the parishes by assisting with their annual tuition assistance commitment to Scotus Central Catholic.

ENROLLMENT & TUITION ASSISTANCE

In the fall of 2015, enrollment increased by 8 students from the previous year to 371. Tuition for the 2015-16 school year increased \$75 per student or an average of 3%. Tuition rates by grade level were: \$2,625 (Grades 7- 8), \$2,675 (Grades 9-10) and \$2,725 (Grades 11-12).

During the 2015-16 school year, \$91,147 was distributed in tuition assistance

benefiting 96 students at Scotus. The sources of tuition assistance were: Scotus \$50,136, Children's Scholarship Fund \$9,300, the Archdiocese of Omaha \$26,000 and local scholarships \$11,228. Also in 2015-16, 12 students participated in the federal free lunch program, and 27 students participated in the federal reduced lunch program.

STANDARDIZED TESTING

94% of the Scotus Class of 2016 (60 of 64) took the ACT test and the Class of 2016 composite score average was 25.5 -- compared with the 2016 Nebraska state average of 21.4 and the 2016 national average of 20.8. The Scotus Class of 2016's average STEM score was 25.9 compared with the state average of 21.4. The Scotus 2016 class composite score was the second highest in school history (the highest score was 25.9 in 2015). 2016 sub scores compared with the Nebraska (state) and national averages were:

According to the American College Testing Program, a student's potential success in college can be predicted by their ACT scores; and ACT has established college readiness benchmark ACT scores for College English Composition (18 on the ACT English Test), College Algebra (22 on the ACT Math Test), College Social

Science (22 on the ACT Reading Test) and College Biology (23 on the ACT Science Test). Attaining a benchmark ACT score will predict that a student will have a 50% chance of receiving a B or higher or a 75% chance of receiving a C or higher in the corresponding college courses.

CHILDREN'S SCHOLARSHIP FUND

Participation in the Children's Scholarship Fund program continued this year with a fundraising goal of \$24,000—and the three Columbus parishes raised \$24,013.65 during the 2015-16 school year. The money was sent to Omaha and in return the Columbus Catholic schools received back a total of \$61,200 in scholarships benefiting 73 students for the 2016-17 school year. For each dollar raised and sent to Omaha, Columbus was guaranteed to receive back \$1.50. Columbus actually received back \$2.55 for each dollar raised—a very good return! SCHOOL IMPROVEMENT PROCESS

During the 2014-15 school year Scotus Central Catholic High School developed a plan to promote the professional development of its faculty. This past year (2015-16), school improvement was centered on implementing the plan for professional development of the faculty.

A year ago Scotus received an Ignite the Faith grant and approximately half of the grant was used to expand the school's wireless network with the addition of access points and enhance the bandwidth of the network. This year, the remaining \$85,000 of the grant was used to increase the speed and performance of the school's servers and wireless network. Additionally gala supporters contributed \$15,495 toward the purchase of I-pads for the teachers. The teachers in turn requested the money be used to purchase 78 Lenova notebooks for student classroom use.

The goal of school improvement at Scotus Central Catholic High School remains centered on improving academic performance and learning opportunities. Both staff development and technology upgrades/increased access have the potential to positively impact education and academic performance at Scotus Central Catholic.

2015-16 FUNDRAISING / DONATION INCOME

SEF 14 UPDATE

This three-year campaign, launched in the fall of 2013 received pledges totaling \$1,330,921 to be paid over calendar years 2014-2016 and to sponsor the following goals: 1) \$900,000 over three years to keep tuition costs affordable for school families, 2) \$200,000 to make loan payments over 3 years for the heating and air conditioning system installed six years ago, 3) \$100,000 to replace the Dowd Activity Center bleachers (a safety issue), and 4) \$100,000 to complete the purchase of two homes to the north of the school, move the homes and provide off-street parking for students (a safety issue.) At the conclusion of August 2016, the SEF 14 campaign had finished 32 of the 36 pledge payment months and pledge receipts totaled \$1,153,734.91. Through SEF 14, the school has made required HVAC loan payments and distributed an average of \$25,000 monthly to support tuition assistance and balance the budget. The campaign also provided for the purchase of new bleachers in the Dowd Center and initial construction work of the new north parking lot.

ANNUAL GIFTS

The fall 2015 annual appeal received 621 donations totaling \$142,244.06 and exceeded the \$65,000 goal to support the purchase of a Ford Transit, refinish the Memorial Hall stage floor, install a drop ceiling and LED lighting in the biology lab and purchase an auto scrubber and snow plow for the maintenance area. The additional funds were used to install a drop ceiling and LED lighting in the chemistry and life sciences labs, and replace desks and carpet in the main office. Annual Appeal campaign expenses totaled \$715.08. The Shamrock Lottery had a net of \$6,136 and those proceeds supported the purchase of half racks for the weight room. The Gala dinner/auction had net proceeds of \$198,683 which was used to balance the school's annual budget. And during the Gala an additional \$15,495 was raised to purchase 78 new notebooks for students to use in the classroom. The Gala's Chuck Sand Memorial Grain Train provided grain donations totaling \$5,059. Receipts from the 3rd annual Columbus Big Give were \$3,611.21 supporting the purchase of new power half racks for the weight room. The 9th annual **Shamrock Open** raised \$9,816 also directed to half racks. Memorial income totaled \$18,879.

Scotus received 41 annual gifts totaling \$85,352.10. Only two unrestricted gifts were receipted (\$2,000, \$10,000) and they were applied to the building fund. Restricted gifts included: \$20,000 to establish the endowed Helen Shadle Memorial Scholarship, \$10,000 for the football program, \$6,000 for the Dave & Norma Duren Family Scholarship, \$4,000 for the endowed Buggi Scholarship, \$2,000 for the endowed Hroza Scholarship, \$2,000 for the annually funded Goins Scholarship, \$1,540 for painting the school's main office, \$1,400 for a new concert

bass drum, \$1,000 for the Feehan Scholarship, \$1,000 for the athletic training room, \$1,000 for the Pyramid of Success scholarship, \$1,000 for the new north parking lot, \$500 for the speech team and \$1,741.10 to fund other scholarships and academic departments. Also included was \$5,000 from the Shamrock Booster Club for the general fund and \$13,825 from the Scotus Mothers Booster Club to purchase: a stair dolly (\$200), electrical stimulation/ultrasound machine for the athletic training room (\$3,800), sousaphone (\$3,825), petri dish incubator (\$550), books (\$450) and Memorial Hall folding chairs (\$5,000.) Scotus also received restricted gifts totaling \$1,251 to pay the annual premiums for three planned gift life insurance policies the school owns.

CAPITAL IMPROVEMENT DEBT

The school originally borrowed \$1.1 million dollars at an interest rate of 5.5% to assist with the capital improvement expenses of the 2008 HVAC installation and locker room renovation (partially funded by the Legacy Capital Campaign.) This debt was refinanced in the spring of 2012 at an interest rate of 3.75%. Through assets returned to the local parishes from the Archdiocese's Ignite the Faith Campaign, the parishes designated a portion of the returned funds to support Scotus. In the fiscal year Scotus received \$43,817.92 to help retire the HVAC debt; and at the conclusion of the 2015-16 fiscal year the remaining HVAC debt was \$196,000 (down from \$454,591 at the conclusion of the 2014-15 fiscal year.) Regular loan payments on the debt are funded by SEF campaign support.

ENDOWMENT - Market Values 8/31/16 and Distributions Fiscal 2015-16

Combined endowment fund market values at the conclusion of the fiscal year (August 31, 2016) was \$8,534,062 including \$5,929,505 (locally managed funds) and \$2,604,557 (funds managed through the Archdiocese). During the fiscal year a total of \$26,668 was added to the endowment. Of this amount, \$26,268 was restricted for endowed scholarship support and \$400 was added to the general endowment fund. Fiscal year distributions received by the school totaled \$318,324.

When endowment distributions are factored in to the overall annual budget, they account for slightly more than 11% of budgeted income. While this may seem to be a modest figure, when endowment support is viewed on a historical level, the impact of the endowment is much easier to appreciate. In the last ten years, some of which were impacted by the Great Recession, endowment distributions to the Scotus general fund totaled nearly \$2.9 million dollars!

2015-16 HIGHLIGHTS

Awards in Sports. Of the 13 combined girls and boys sports offered, there were 10 district championships and two 2nd place finishes. The boys' football and soccer teams each won their state championship. The girls finished in the top 10 state rankings in 3 of 6 sports: volleyball (4th), golf (10th), soccer (5th). Every boys team finished in the top 5 state rankings: cross country (4th), football (1st), basketball (3rd), wrestling (5th), golf (3rd), track (3rd), soccer (1st). Scotus also received the 2015-16 Class C All-School Division & Class C Boys Division NSAA Cups!

Golf. The girls' varsity golf team finished in 10th place at the state Class C golf tourney. Junior Emerson Belitz finished in 11th place individually. The boys' golf team finished in 3rd place at the state Class B tourney and was led by senior Brandon Johnston who finished in 12th place individually.

Cross Country. The boy's team finished fourth at state behind the individual second place finish of Nathan Ostdiek. The girls' team finished in 13th place at state.

Volleyball. Scotus ended the season with a 25-8 record and ranked 4th in Class C1. They finished State in 4th place winning the consolation match against second seeded Chadron. Class C-1 First Team All-State: Maeghan Pieper, Courtney Labenz. All-State Honorable Mention: Kim Stutzman, Morgan Thorson, Sarah Schumacher. Maeghan Pieper played in the *Nebraska Coaches Association* match in July.

Football. Scotus defeated Norfolk Catholic 32-27 at the University of Nebraska-Lincoln Memorial Stadium to capture the Class C-1 state championship. It was the Shamrocks' first state football title in 22 years and the fourth football title in school history including 1967 (Class C), 1984 (Class B), 1993 (Class B) and 2015 (Class C-1.) The Shamrocks finished the year 13-1 under head coach Tyler Linder. Named 1st Team All-State: Carson Fuchser, Baeley Pelster, Jake Bos and Marcus Dodson. All- State Honorable Mention: Cole Harrington, Nathan Tworek, Jackson Kumpf, Evan Chohon and Sam Novicki. *Husker Prep Report* named Tyler Linder, as their Coach of the Year. Jake Bos played in the annual *Shrine Football* game.

Basketball. The boys' team finished in 3rd place at the state tourney and earned a school record 25th win on the season (25-4.) All-State first team: Dalton Taylor. All-State Honorable Mention: Jackson Kumpf, Cody Mroczek, Nathan Ostdiek, Miles Putnam. The Shamrock girls ended their year at 14-9 with All State Honorable Mention honors going to: Shania Borchers, Allie Johnson, Emma Strecker, Kendra Wiese.

Wrestling. In its fourth year of varsity competition, Scotus placed 5th overall at the State wrestling tourney and state medalists were: seniors, Marcus Dodson (1st), Jake Bos (2nd), and Seth Gutzmer (4th); and juniors, Wyatt Gutzmer (3rd) and Layton Mullinix (4th). Two weeks later Scotus finished in fourth place at the state duals tournament. Also during the season, the team captured its fourth straight Centennial Conference Tournament title and won the B-3 district title—the first district title in program history. Nine Shamrock wrestlers qualified for

the state wrestling tourney. Jake Bos and Marcus Dodson also wrestled in the NSWCA All-Star Classic Dual in June.

Track & Field. The girls team placed 9th at the state meet and the boys team finished in 3rd place. Girls state results included: Shot Put - Marika

Spencer (3rd), Discus – Marika Spencer (2nd); 3200 M Relay (6th) - Jessica Lahm, Grace Odbert, Ashley Foreman, Sarah Schumacher; 300 M Hurdles-Bailey Lehr (6th); 1600 M Relay (3rd) -Grace Odbert, Sarah Schumacher, Bailey Lehr, Jessica Lahm. Soccer. Coached by Jon Brezenski, the Scotus boys captured their third consecutive Class B state championship—something no other Nebraska boys soccer team has ever accomplished. The Shamrocks (17-3) handed Elkhorn South HS (18-1) their only loss of the year by a score of 1-0. This was the Shamrocks' 6th state title in program history (2015, 2014, 2009, 2001 and 1997). Powerlifting. The Scotus powerlifting team competed in the Class B state tournament with senior Savannah Robertson capturing first place in the girl's 148 pound division with a 275 pound squat, a 145 pound bench press and a 285 pound deadlift for a 705 pound total. Freshman Jackie Robledo placed third in the 165 pound division. For the Scotus boys, junior Will Sonderman was first in the 198 pound class with a 430 pound squat, 245 pound bench press and 465 pound deadlift for a 1,140 pound total. Senior Nate Tworek also captured first place at 220 pounds with a 450 squat, 315 bench press and 460 deadlift for a 1,225 pound total. Senior Ryan Mustard finished third at 181 pounds with a 1,020 pound total and sophomore Brandon Huynh was third in the 275 pound class with a 1,250 pound total.

Cheerleading. The Scotus cheer squad completed a 3-day National Cheer Association camp at UNL. The girls earned the Spirit Stick all three days, won Champion Chant Varsity division, and won the camp Spirit Award for the third year in a row. They also had 5 All American nominees, seniors: Nikki Hiner, Alayna Wilson; juniors: Grace Wickham, Natalie Brutty and sophomore Kendra Korger. Alayna Wilson was selected as an All American and she also won the Individual Camp Leadership award. Pin It Forward winners were: Grace Wickham, Alyana Wilson and sophomore Rebekah Hergott.

Alumni/nae Soccer. The 2016 Scotus Alumni/Alumnae Soccer Tournament was held on August 5-6, 2016, at the Warren & Shirley McLaughlin Activity Field. Over 140 players participated in this year's tournament, making for another successful weekend of Shamrocks celebrating the storied tradition of Scotus athletics. The tournament was filled with highly competitive games in the men's and women's divisions.

Journalism. The Scotus journalism students, taught by Angie (Naughtin) Rusher '95 finished in 3rd place as a team in Class B at State Journalism—scoring 272 points and within 6 points of 2nd place and 14 points from first!

Scotus had 4 state champions; took 1st, 2nd, and 3rd in Newspaper Layout; 1st, 2nd, and 4th in Feature Photography; medaled 18 times out of a possible 26 entries and 14 out of 16 students medaled! Mock Trial. The junior mock trial team placed 5th at the State Competition in Omaha.

Craft Boutique. The Scotus Mothers Craft Boutique was held on December 6th and it was a success with more than 1,700 in attendance. Proceeds from the event have been used to make substantial capital improvements at Scotus and to fund many items from the faculty/staff wish list.

Jump for Heart. 140 3rd and 4th graders from the three Columbus Catholic elementary schools raised \$9,187.32 in the Dowd Center to fight heart disease.

Teacher Award. The William and Barbara Gerhold Family Teacher of the Year was Charlotte (Micek '68) Beran of St. Anthony School.

Blood Drive. The Scotus blood drive conducted for the Red Cross provided 118 whole blood units and 10 double red donor units for a total of 128 productive units. Participants included Scotus sophomores, juniors and seniors, staff, parents, friends and alumni/nae.

Living the Faith. Scotus students contributed more than 7,000 hours of service to school, community and church in the last year.

Technology. Through donor support at the 2016 Gala, Scotus purchased 78 new Lenova notebooks for student use in the classroom. Scotus also spent the remaining technology grant money awarded in 2015 from the Ignite the Faith Campaign on a new Hyper Converged Solution (a cluster of four servers) to support the school's existing network and programs. The server cluster was installed in the summer of 2016 and provided a tremendous increase in speed and performance. For example, under the old system, it took 50 minutes to reboot the PowerSchool program, and under the new server cluster the PowerSchool reboot now takes 4 minutes.

Retirements. Retiring at the end of the school year were: Wayne Morfeld, school president; Peg Morfeld, science teacher; John Petersen, mathematics teacher/coach; and Gary Puetz, activities director. Wayne has been the Scotus president/principal for ten years and prior to that he was the Scotus principal for 6 years and a public school teacher and coach for 29 years. Peg has taught at Scotus for 6 years and has an additional 37 years of public school teaching experience. John began teaching at Scotus in 1977 and he had five years of previous teaching experience in other schools. Gary began his Shamrock career in 1975 and had 3 years of previous teaching experience at Newcastle HS. Also leaving the faculty were Danielle Masur and Anne Novicki.

East Activity Field. Scotus will lose the current East Activity Field used for soccer practices when the new 12th Avenue overpass is constructed. (Prior to the development of the McLaughlin Activity Field, this East field is where Shamrock football teams practiced.) The school entered into negotiations to determine the value of the East Activity Field and how the school would be compensated for the loss of this resource. The school also engaged in negotiations to expand the McLaughlin Activity Field from a single east-west practice field to two north-south practice fields. If the McLaughlin Field can be expanded, the school will have a replacement solution for the East Activity Field.

New President. Jeff Ohnoutka became the next Scotus President/Principal effective July 1, 2016. Jeff has been a teacher at Scotus for 11 years, the last four years also as assistant principal and he coached the boys' basketball team the last nine years.
