NOTE: 34 Scotus students were eligible for the federal free (n=18) and reduced (n=16) lunch program compared with a total of 48 the previous year. However, in response to the pandemic and through the CARES Act, the government paid for the school lunches of all Scotus students for a second entire year.

ENROLLMENT & TUITION ASSISTANCE

Enrollment for the 2021-22 school year was 371 - representing a decrease of 4 students from the previous year. The student body was comprised of the following religious affiliations: Roman Catholic (352), Lutheran (6), Christian (4), Baptist (2), Methodist (1), 1C (1) not reporting (5). Tuition for 2021-22 was \$3,400 for all grade levels. There were no fees charged.

At the start of the 2021-22 school year, \$154,959 was distributed in tuition assistance (including \$10,000 in John Duns Scotus awards) to 244 students.

PARISH TUITION ASSISTANCE

The three Columbus parishes support the annual Scotus budget with parish tuition assistance—effectively providing a scholarship to each Scotus student that was valued at \$2,177 in the 2021-22 fiscal year. St. Anthony parish provided \$157,840; St. Bonaventure provided \$300,000 and St. Isidore provided \$350,080 with the support levels based upon the number of students enrolled from each parish at Scotus. In addition, parish tuition assistance is supplemented with the annual income distribution (\$192,395 in 2021-22) received from the Walter & Josephine Rambour endowed fund. This endowed fund has a corpus value of \$3,142,881 and was established to support the parishes by assisting with their annual tuition assistance support to Scotus Central Catholic.

CHILDREN'S SCHOLARSHIP FUND

2021-22 CSF Scholarships

Participation in the **Children's Scholarship Fund** program continued and the Columbus parishes raised \$17,592.58 during the 2020-21 school year. The money was sent to Omaha and in return the Columbus Catholic schools received back a total of \$42,000 in scholarships benefiting 51 students for the 2021-22 school year. Scholarships were down because CSF-Omaha's fundraising was down due to the pandemic. A summary of the scholarships follows:

ENDOWMENT - Market Values and Distributions Fiscal 2021-2022

Combined endowment fund market values at the conclusion of the fiscal year (June 30, 2022) were \$9,331,668 including \$6,668,213 (locally managed funds) and \$2,663,455 (funds managed through the Archdiocese.) Overall, the endowment market value was down \$1,774,944 from the same date in the previous year. During the fiscal year, a total of \$22,125 was added to the endowment. Of this amount, \$21,750 was restricted to endowed scholarships and \$375 was added to the general endowment. Fiscal year distributions received by the school totaled \$502,963.58.

STANDARDIZED TESTING

47 of the 54 members of the Scotus Class of 2021 took the ACT test. (Information on the Class of 2022 will not be available until late in the year, 2022.) The 2021 ACT Class Profile composite score for Scotus was 24.6 which was tied for fourth highest in school history. 2021 sub scores compared with the Nebraska (state) and national averages were:

According to the American College Testing Program, a student's potential success in college can be predicted by their ACT scores; and ACT has established college readiness benchmark ACT scores for College English Composition (18 on the ACT English Test), College Algebra (22 on the ACT Math Test), College Social Science (22 on the ACT Reading Test) and College Biology (23 on the ACT Science Test.) Attaining a benchmark ACT score will predict that a student will have a 50% chance of receiving a B or higher or a 75% chance of receiving a C or higher in the corresponding college courses.

OTHER HIGHLIGHTS

• Faculty and staff receiving **years of service recognition** this year included: 5 years - Clyde Ericson, Maria Del Rocio Garcia (cafeteria); 15 years - Deb Ohnoutka; 25 years - John Schueth; 30 years - Pat Brockhaus, Jane Dusel-Misfeldt; 35 years - Tom Salyard, Janet Tooley. The recipient of the 24th annual **William and Barbara Gerhold Family Teacher of the Year Award** for a Columbus Catholic schools' teacher was Joan Pauley. Joan has taught music at St. Isidore and St. Anthony schools for 31 years. Tom Salyard, Janet Tooley and Merlin Lahm were honored with the 2022 Scotus **Outstanding Service Award**.

• Scotus welcomed the following new staff members for the school year: **Fr. Jim Heithoff** (retired priest of the Grand Island Diocese) as part-time assistant for campus ministry; **Brady Vancura**, Assistant Principal; **Kristine Wurtz**, interim business; **Kristi Heng**, interim moderator of Spanish distance learning; **Ryan Baker**, strength training & physical education; and **Sandy Vancura**, interim English. Mathematics courses taught the previous year by Alison Timoney were assumed on an interim basis by existing Scotus faculty.

• At the end of the 2021-22 school year, **Scotus said farewell** to part-time English instructor, Becki Zanardi; interim instructor Kristi Heng and long-time activities office/development office assistant, Annette Hash. New faculty announced for the 2022-23 school year included: Autumn Johnson, Spanish; Cody Mroczek, Business; Wendy Shotkoski, Mathematics and Alaina Wallick, English.

• Naming of the 23rd annual **Alumna and Alumnus of the Year** and new inductees to the **Shamrock Hall of Fame** was postponed to the fall of 2022. The **14th annual alumni/nae soccer tournament** had 125 players in the men's and women's divisions. The **39th annual alumni/nae basketball tournament** drew 125 men & women participants. Numbers for both tourneys were still influenced by the pandemic. The **Shamrock Open** golf tourney had 90 participants.

• **John Petersen Court**. The new gym floor in the Dowd Activity Center was dedicated in the name of Scotus coaching legend, John Petersen. Coach Petersen was the volleyball coach for 37 seasons at Scotus. He led the Shamrocks to 15 state championships, seven runner-up finishes, and the Shamrocks made the state finals 14 consecutive years--a streak that is unmatched in Nebraska high school sports. He also coached girls' basketball for 23 seasons bringing home 3 state titles and one runner-up finish.

• In **District Music**, Scotus students earned 24 Superior (I) and 4 Excellent (II) scores: Receiving Outstanding Performance Awards were: Hannah Pflum, Soprano Clarinet Solo; and Alaina Dierman, Stephanie Hoenk, Jasmine Jackson, Hannah Pflum, Emilliano Rodriguez, and Vijayalakshmi Wemhoff, Saxophone Ensemble. Receiving Outstanding Performance Honorable Mention was Luke Przymus, Tenor/Bass Voice. The Scotus marching band received a superior Division I rating at the Harvest of Harmony Parade in Grand Island.

• **Campus Ministry**. The Rock Talk program completed its 3rd year. During the school year, Mass was offered on Tuesdays and Fridays each week in the school chapel at 7:20 a.m. and students led the Divine Mercy Chaplet on Thursdays at 7:20 a.m. in the chapel. The St. Bonaventure Parish perpetual adoration continued in the Scotus chapel. Scotus students participated in the 2021 Life Chain in Columbus on Respect Life Sunday. Attendance at the March for Life in Washington DC was cancelled due to COVID restrictions.

• For the first time in eighteen years, the **speech team** was crowned district champions. As a team, Scotus finished in 7th place at the State Speech Meet. Luke Przymus was the Class B State Runner-up in Serious Prose, Chris Adame and Luke Przymus finished in 3rd place in Duet Acting, and Chris Adame finished in 4th place in Humorous Prose. The Scotus **One-Act Team** presented "Macbeth - A Tale of Darkness" and was named District B3 Champions, placing first with all three judges. The Crew won the Outstanding Theater Tech Award. This was the first time since 2007 that the Shamrocks qualified for state. At State, Scotus finished in 4th place. Senior, Luke Przymus, was named the Outstanding Male Performer. Thirty-Four cast and crew members presented the **musical**, "Anastasia: The Musical" on Feb 11-13 in Memorial Hall.

• 35 students received **Academic All-State** honors during the year. The Scotus Chapter of the **National Honor Society** had 72 members. The **garden club** was formed under STEAM teacher, Betsy Rall's direction. Produce was raised in the courtyard for the community.

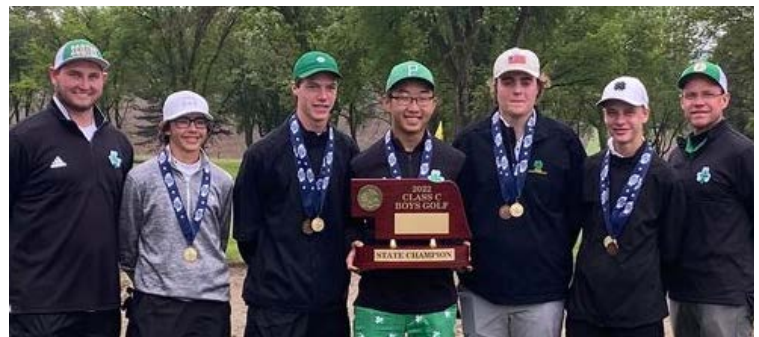
• The Scotus **Journalism team** captured the state 2022 NSAA Class B title for a second straight year. Individual state titles were earned by: Maysa Kuhl (Editorial Cartooning), Ashley Steiner (Yearbook Feature Writing), Kaelyn Dierman (Yearbook Sports Feature Writing) and Hailey Steffensmeier (Broadcast Sports Story).



• **Participation** in athletic activities included: JH volleyball (39), V Volleyball (38), JH Football (57), V Football (50), JH/SH CC (42), Softball (3), Boys Tennis (8), Speech (33), One-Acts (42), Mock Trial (18), Swimming (3), JH Girls Basketball (31), JH boys Wrestling (22), V Wrestling (12), V girls basketball (25), V boys basketball (31), JH girls track (53), JH boys track (52), V girls track (35), V boys track (40), girls soccer (22), boys soccer (28), boys golf (16), baseball (9) and girls tennis (1).

• **Girl's golf** won the conference and district meets, and finished runner-up at state. Sophomore Cecilia Arndt captured the individual state champion medal—a first in school history. The Shamrock **girls' cross-country** team placed 14th at state. The **boys' cross country** did not qualify for state. **Football** finished the season with a 9-2 record and a 7th place state ranking. **Volleyball** ended a great season at 21-11. The **softball** team finished 19-22 with 3 Scotus girls participating. Scotus had eight boys competing in **boys' tennis** and five of the six players who competed at state were Scotus students. **Girls' basketball** finished with a 16-9 record for the season and a #10 state ranking. The

boys' basketball team ended their season with a 4-19 record under first year coach, Mike VunCannon. In **wrestling**, Spencer Wittwer was 1-1 at state and Riley Eickmeier was 2-1 at state, finished the year at 40-11 and a career 100 wins. **Girls' soccer** finished 16-3 and a final state ranking of #4. **Boys' soccer** finished 12-5 and a state ranking of #9. **Girls track** qualified 4 for state and **boys track** qualified 2. **Boys golf** won the state Class C title, which was also the school's overall 50th state championship. 2021-22 FUNDRAISING / DONATION INCOME

SEF 16

The very first Scotus Education Fund drive (SEF 1) began in 1969 with the goal of providing a resource to keep tuition as low as possible for our school families. Traditionally the SEF campaigns have involved three-year pledges. SEF 16 launched in the fall of 2020 with a goal to raise \$1,275,000 to support tuition assistance for three school years (\$1,050,000), underwrite school safety improvements and COVID response measures (\$100,000) and to replace the Dowd Activity Center floor (\$125,000.) As of 6/30/2022 pledges totaled \$1,231,037 (payable over the calendar years 2021-2023.) Work on the Dowd Center court was completed in the summer of 2021.

PLANNED GIFTS

Planned Gifts. Scotus received planned gifts from the estate of Leonard Engler (\$55,847.35) and a life insurance policy distribution from the late Leo Thiele '52 (\$5,776.23.) These donations were used to establish scholarships in the donor's names. Another "living" estate gift was received from Dorie Schrad (\$46,719.23.) Dorie wanted to enjoy seeing her estate gift do good things for the annual appeal, music department and to further support the endowed Don & Dorie Schrad Music Scholarship.

OTHER FUNDRAISING

The **2021-22 Annual Appeal** goal was \$105,000 to support: 1) the cost of tree removal on the south side of the school (\$10,000), 2) installation of new sidewalk and parking on the south side of school (\$45,000), 3) enhance heating in the girl's locker room and in the Dowd Center hallway (\$10,000) and 4) support the new bus lease fund for 2 new busses (\$40,000.) The appeal was successful, raising \$201,333. (Annual appeals are conducted in years when an SEF drive is not conducted.) The **Shamrock Lottery** had net proceeds of \$13,373.83 which was directed to Scotus' Seton Scholarship fund. The **2022 Gala** was presented for the second year at the St. Bonaventure Parish Center and the event was a success raising \$248,000 for the annual budget and an additional \$22,435 for the bus lease fund. The 15th annual **Shamrock Open** was held on June 4, 2022, with 90 participants and a net of \$14,993 for the bus lease fund. Scotus also participated in the second annual archdiocesan-sponsored "**Joy of Giving Day**" on May 18. Net proceeds from the event totaled \$2,936 and were divided equally among the four Columbus Catholic schools to support the purchase of instructional materials. The Scotus Booster Club's annual **Boutique** had net proceeds of nearly \$16,000.

ANNUAL GIFTS

Scotus received annual gifts between 7/1/2021 and 6/30/2022 totaling \$358,138.98. \$22,125.00 was directed to the endowment, all but \$375.00 to support existing endowed scholarships. Other donations included: \$14,571.00 to annually funded scholarships and the scholarship fund, \$1,154.85 to support 3 premium payments for life insurance policies donated to the school, \$9,650.00 for chapel renovation, \$5,700.00 for fine/performing arts, \$10,880.93 directed to purchase Word on Fire bibles for all students, \$80,000.00 for the bus lease fund, \$202,800.00 for the STEAM program, \$3,000.00 for the math/science departments, \$300.00 to purchase first aid kits for classrooms, \$2,520.00 to purchase jackets for soccer, and \$5,437.20 for the general fund.
